**SPECIAL SERVICE TIME AND CALLED MEETING:** On December 4, 2016, there will be only one service to be held at 10:00 AM for the purpose of having a special called meeting following the service to elect members to council and trustee positions, to vote on a call for Pastor and a motion for a school loan authorization. Following the meeting, there will be a catered luncheon in the social hall. Mike Rapier and his Encore staff will be serving the lunch. There will not be an adult Sunday school, however, the children's Sunday school students will still meet at 9:15 AM to practice for the Trinity Trouper's Christmas performance.

**AMENDMENT FOR CALLED MEETING:** A motion will be made at the called Church Congregation meeting on December 4<sup>th</sup> to amend the agenda to include a vote on a request from the school board for approval to borrow money for the purchase of a new school bus. As per the Church Constitution, Bylaws and Continuing Resolutions, Chapter C20.04.e, the school board may not borrow money or purchase or dispose of real estate without the approval of this church's congregation. At the beginning of the school year, the 26-year old bus was too costly to be repaired and the school started to use the church's van to transport students to school. The van itself is getting old and was not intended to be used as a long-term solution. It was determined that a new bus could be purchased or leased at a cost equal to or less than the budgeted repair costs. A favorable seven-year purchase loan from Bayport Credit Union would insure a more reliable and safe ride for the students. Acquisition of the bus is pending approval from the congregation to allow the school board to borrow the money.

**SOCIAL MINISTRY CHRISTMAS FOOD DRIVE:** Please bring in canned and boxed food for the Christmas food collection by our Social Ministry committee. Please use the brown bags that were available for Thanksgiving food collection. The same type of food items are requested. Boxes to place single food items will also be available in the church library. Food items are due no later than **December 11th**. We filled seven large laundry baskets full of items to for seven families to enjoy a wonderful Thanksgiving feast including a turkey. Trinity members are so gracious. Thank you so much!

## 2016 COUNCIL NOMINEE BIOGRAPHIES:

**Jessica Moye** (*Editor note: Jessica is seeking a second term on Church Council.*): My family have been members of Trinity since 1986. My parents, Jack and Wendy Kowalski became youth advisors shortly after joining the church. So around the age of five I was happily tagging along to the youth meetings and activities and interacting with all the older youth members. I liked to think of myself as an honorary member and was so excited when I could officially become a youth group member in 6th grade. Being around the youth growing up I saw how much fun they had doing the service projects that I always preferred those projects and helping others more than the “fun” trips. I was in the children’s choir when Don Golden was the church organist. I attended Vacation Bible School until I was too old then I helped my mother teach. I attended Sunday School regularly and later in High School, taught 1st and 2nd grade Sunday School for a couple of years. I also assisted my mother when she was the Sunday School Superintendent and I have served as an acolyte or crucifer for several years. In 2009 my daughter Michaela Moye was born. She started Sunday School with Linda Madler in the Musikgarten class. My hope is that my daughter will grow up in this church and have the same experience I had of growing up with a great church family. In addition to being a full-time mom I work part time as a sales representative for Mars candy.

**Sounthone Mynoymany** (*Editor note: Sounthone is seeking a second term on Church Council.*): Born in Vientiane, Laos in 1967, I resided in Laos until the age of 9, at which time my family fled across the Mekong River into northern Thailand. In 1981, Trinity Lutheran Church sponsored my family to immigrate to Newport News, where we have been members of Trinity Lutheran ever since. Educated in the Newport News school system and a graduate of Menchville High School, I pursued a career in the local grocery/food service industry, a field in which I am still employed, albeit with Nestle Foods as a wholesale sales representative and distributor. I am an active participant in the church, serving regularly as a clergy cross bearer, communion assistant, and sometimes acolyte with my son Matthew. I also volunteer with PORT, and until recently, my wife and I were the sponsors of the Young Adult Dinners. Being re-elected to the Council will enable me to put my years in the church as a parishioner to good use and provide another opportunity to continue to serve God and my community.

**Todd Recupero:** I have been serving as an interim voting member on Church Council for the past few months. Additionally, I served on the Transition Team to identify Trinity’s needs for the new pastoral selection process. I became a member of Trinity in 1999 through marriage to then Natalie Lindfors. Since then, we have raised our family through Trinity, having our children baptized here and their first communions. They have a close connection to Trinity Lutheran School as well and our son Carter is currently enrolled there. At Trinity, I have served as a presenter, nursery aide, and volunteered during the 2016 Youth Group Yard Sale.

I was born in Harrisburg, PA in 1972 and was baptized at Trinity Lutheran Church in Steelton, PA. I moved to Virginia with my parents in 1980. We attended St. Timothy’s Lutheran Church in Norfolk where I was involved in the youth group, volunteered with the homeless sheltering program, served as an acolyte, crucifer, and as an assistant minister. I served 8 years in the United States Marine Corps and received an honorable discharge. I then served the City of Virginia Beach as a police officer for 17 years until my retirement in 2015. Recently, I was conferred with a Master’s of Science Administration/Global and Homeland Security degree from the University of Phoenix, where I graduated with a 4.0 GPA. Locally, my family volunteers with the Alzheimer’s Association. I serve as an Assistant Den Leader for Carter’s Cub Scout Pack 48 in Newport News, and belong to several organizations including the Fraternal Order of Police and the American Legion.

**Laura Davis:** I have been a life-long Lutheran, formerly member of St. Peter’s, Toms Brook; St. Luke’s, Richmond, and Christ, Richmond. I have been a member of Trinity since 1973. I was married to Richard Davis in 1977 at Trinity, where we also met. We have a daughter, Ellen Davis Badgley who was baptized and confirmed at Trinity. I received a BA degree from Roanoke College in 1968 and a MS degree from Florida State University in 1969. My professional career includes a Reference Specialist at the Virginia State Library, an Acquisitions Librarian at Christopher Newport College, and a Library Media Specialist in the Newport News Public School system.

My community involvement includes the Junior Women’s Club of Hilton Village (various offices), Woman’s Club of Hilton Village, Woman’s Club of Hampton Roads (various offices including President), Peninsula

Piecemakers Quilt Guild, Golden Thimble Needlecraft Guild, PTA at Hilton Elementary, Riverside Elementary, Hines Middle, and Warwick High Schools (various offices at each level), Newport News Public Schools TAG Advisory Board, Newport News Child Abuse Prevention Committee, Newport News Historical Committee, Virginia Peninsula Alpha Phi Alumnae (various offices, including President). I have served the congregation as part of the Chancel Choir since 1973, two terms on Congregational Council, Sunday School teacher, Nursery volunteer, Christian Education Committee, Chairman, Worship and Music Committee, Altar Guild, Lay Reader, President, Lutheran Church Women, Helped organize and volunteered with Respite Day Care, Helped organize and served as Co-Librarian for church library, Represented Trinity at Virginia Synod Assembly, and Attended Power in the Spirit (4 summers). I am currently the Chair of the Worship and Music Committee and have been serving as an interim on the Church Council.

**Michelle Carpenter:** I grew up in an ELCA Lutheran church in Ohio where I was baptized and confirmed. I was active in the Lutheran Youth Group growing up. I attended Miami University in Oxford Ohio, where I met my husband, Chip. We were married in 1991. I attended Graduate School in Louisiana before joining Chip in Hampton Roads who was in the Navy. We moved to Huntington Heights in 2000, and have been attending Trinity Lutheran ever since. We have two children, Lois Jean and Carl, both of whom were baptized and received first communion at Trinity. I teach marketing at ODU's Strome College of Business. Additionally, I am serving as the leader of Trinity's Girl Scout Troop 4170 since 2010.

**Dave Roselius:** I have been a member of Trinity since 2003, not long after Diane and I moved into our home in Smithfield. For some time I simply attended church regularly, but gradually began to assume Sunday worship duties, serving as a presenter or usher with Diane, and later as an occasional lector. Due to Diane's artistic talents, I got to help her paint the murals downstairs, and when Pastor Guy wanted a Nativity table, I was able to make one. My religious background is somewhat vague, growing up as the child of an Air Force officer and moving from place to place. When I was unable to verify my baptism at my grandparent's church, Pastor Guy baptized me at Trinity in November 2012, bringing me fully into the fold.

**Dee Klapperich:** I have been a member of Trinity since 1986. I have served on the Social Ministry Committee, Church Council and served as Recording Secretary of Council for a number of years, Stephen Ministry, Call Committee for the Minister of Music, Sunday School Teacher, Youth Group Leader, Trinity Women of the ELCA President and Secretary/Treasurer, Columbarium Committee, Alter Guild, Usher, Lay Reader, and Archives Committee. I completed Adult Confirmation Instruction and the two-year Crossways Bible Study Class receiving a certificate from Crossways International. I have served as delegate to the Virginia Synodical Women's Organization Conventions and congregational delegate to the Virginia Synod Convention.

My community involvement includes serving as a volunteer recorder at a White House Conference on Aging in Washington. Served the Boy Scouts of America as Tiger Cub and Cub Scout Den Leader, Troop Committee Chairman, District Commissioner of Newport News, Served on BSA Woodbadge Courses (earned 3 beads), and received the Silver Beaver Award. I am married to Butch and we have one son Dan (deceased), two Stepsons Joe and John. Between Butch, Joe, John and I, we have slightly over 80 years of military services (Navy and Army).
